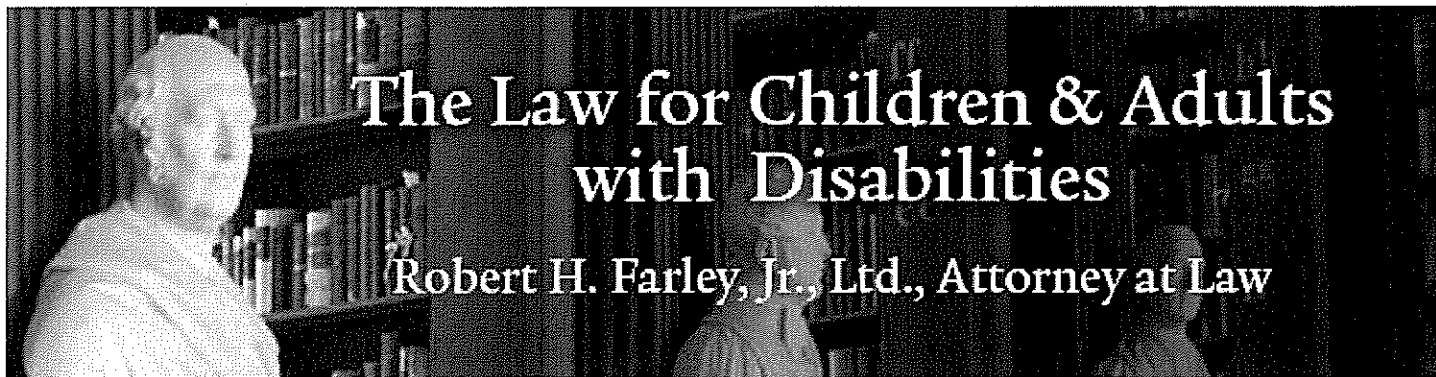

Federal Class Action Filed Against State of Illinois Due to the Failure of the State to Pay Adequate Nursing Rates

On November 20, 2015, Attorney Robert H. Farley, Jr. plus a blue ribbon legal team, filed a Federal Class Action Lawsuit against the State of Illinois due to the failure of the State to pay adequate nursing rates.

There are approximately 1,200 children who have been approved by the State of Illinois for in-home skilled nursing services, however the nursing agencies are unable to staff the approved hours due to the low reimbursement rate approved by the State for a registered nurse (RN) or a licensed practical nurse (LPN). Lawyers for the Plaintiffs and proposed Class have a pending Motion for a Temporary Restraining Order and Preliminary Injunction to require the State to take immediate action so that all the approved nursing hours can be delivered to the medically necessary children.
